1. Agreement to Terms

Participation in Pizza Pursuit (the "Contest") constitutes entrant's full and unconditional agreement with and acceptance of these Terms and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Terms. 3. Eligibility

The Contest is open to legal residents of Canada who are over the age of sixteen (16) at the start of the Contest Period (each an “entrant”). Sponsor’s and its affiliates’, current and former directors, officers, employees, contractors, agents, representatives, and promotional and other vendor agencies involved in the promotion of the Contest, and each of their immediate family members (spouse, parents, siblings, and children) and any person with whom such persons are living, whether related or not, are not eligible to enter the Contest.

2. Enter the unique PIN found on the purchase receipt or the flyer accompanying any order. Each PIN can be used to play Pizza Pursuit once, with one (1) to five (5) players. Each player is an individual entrant in the Contest.
3. Enter all identifying information requested; and

4. Play the Pizza Pursuit game alone or with up to four (4) additional players in accordance with the instructions provided in section 6 below for a chance to win from one of three tiers of prizes described below.

- In each game there are a total of twenty-one (21) questions, over three (3) rounds. A player has thirty (30) seconds to answer each question.
- Each correct answer earns the player one-hundred and fifty (150) points and one (1) half pizza slice within the game.
- For collecting one (1) full pizza slice (by providing two (2) correct answers) within the game, player may receive an instant win prize in accordance with these Terms.
